- (c) The application fee is US\$ (500) and the fee shall not be reimbursed whether the application is approved or not.
- (d) If committed or involved in any crime, the punishment as to the relevant Country's Court of Law shall be served.
- (e) I shall be the tax payable person in accord with the existing laws, rules, procedures, directives and shall be the person who respects the sovereignty and desires to take consideration and is able to assist for the interests of the country.
